Ceremonial Items

<u>25-0021 Proclamation Recognizing the 60th Anniversary of the Durham Soil and Water</u> Conservation District as a Stand-Alone District

Commissioner Burton read the following proclamation:

DURHAM SOIL AND WATER CONSERVATION DISTRICT 60TH ANNIVERSARY | 2025

- WHEREAS, In 1937 Dr. Hugh Hammond Bennett, a North Carolina native, urged President Franklin D. Roosevelt to create local soil and water conservation districts across the United States to develop locally led conservation programs; and
- WHEREAS, From March 22, 1937, to February 2, 1965, the Durham Soil and Water Conservation District was part of the multi-county Upper Neuse River Soil Conservation District, that was instrumental in improving the county's natural resources; and
- **WHEREAS,** The Durham Soil and Water Conservation District was officially established as a single-county conservation district on February 2, 1965; and
- WHEREAS, The Durham Soil and Water Conservation District is one of 96 conservation districts which cover all of North Carolina and is led by 3 elected and 2 appointed Durham residents known as Conservation District Supervisors who provide leadership for local, voluntary stewardship of natural resources; and
- **WHEREAS,** The Durham County's natural resources are renewable and more valuable than the golden leaf for which the County is famous; and
- WHEREAS, The Durham Soil and Water Conservation District's mission is to conserve, enhance and promote the natural resources of Durham County by providing technical assistance, environmental education information and economic incentives to County residents and by exhibiting a diversified program to meet its changing needs; and
- **WHEREAS,** The Durham Soil and Water Conservation District is a state and nationally recognized leader in natural resource conservation for its diverse and innovative programs; and
- **WHEREAS,** February 2, 2025, will mark the 60th anniversary of Durham Soil and Water Conservation District and this year represents a significant milestone in the stewardship of natural resources.

NOW THEREFORE, I, Nida Allam and on behalf of the Durham Board of County Commissioners do hereby proclaim February 2, 2025, as the

"60TH ANNIVERSARY OF THE DURHAM SOIL AND WATER CONSERVATION DISTRICT" and commend its celebration to all citizens.

25-0024 Resolution – Honoring the Life of Dr. E. Lavonia Allison

Commissioner Valentine read the following resolution:

DR. E. LAVONIA ALLISON

- WHEREAS, Dr. E. Lavonia Allison was born in Durham, NC, raised by loving parents and completed elementary and secondary public schools of Durham, graduating with honors from Hillside High School as the Class Salutatorian; and
- WHEREAS, she attended Hampton Institute, now Hampton University, graduating Cum Laude with a B. S. degree in Science, and earning a M.A Degree in Health Education, graduating Magna Cum Laude from Hampton University; and
- **WHEREAS,** she additionally earned a doctorate in Higher Education Administration from New York University, graduating Summa Cum Laude; and
- **WHEREAS,** Dr. Allison embarked on a noteworthy career teaching health and physical education at Whitted Junior High School in Durham, and at North Carolina Central University; and
- WHEREAS, in 1974. she became Director of the N.C. Manpower Development Program, now known as N.C. Health Careers Access Program, where she worked tirelessly to significantly increase the number of African Americans and Native Americans entering health professions; and
- **WHEREAS,** she became an effective advocate working for meaningful change, equality and equity, striving to eliminate racial, economic and educational barriers locally, nationally, and beyond; and
- WHEREAS, Dr. Allison was thoroughly involved in the political landscape of our community, state and nation with memberships in various organizations including, The Durham Community on the Affairs of Black People, where she served as Chair for 14 years; Delegate, Democratic National Convention and Durham County, District and State Democratic Conventions; Congressional Black Caucus; National Black Women's Political Congress; Durham Alumnae Chapter, Delta Sigma Theta Sorority, and more; and
- WHEREAS, she received numerous awards over her legendary career including The Order of the Long Leaf Pine Award; Who's Who Among Women in Politics; Durham Committee

Citizen of the Year Award; Life Time Membership NAACP and National Council of Negro Women; the Longest Congressional Black Caucus Attendee Award; and many more, and

WHEREAS,

we pause to honor the life and legacy of Dr. E. Lavonia Allison who contributed so much to our Durham community, the State of North Carolina and the nation as an activist, educator, mentor, visionary leader, and effective advocate who was not afraid to speak truth to power to help improve the quality of life for all.

NOW, THEREFORE, BE IT RESOLVED, that we, the members of the Durham County Board of Commissioners, do hereby resolve to pay tribute to

DR. E. LAVONIA ALLISON

An amazing life force who shared her tenacity, determination, sense of fairness and work ethic over her lifetime. We call upon all citizens of Durham County to remember how she fought tirelessly to improve the quality of life for generations to come. Her legacy will continue to provide enduring inspiration to all who believe in justice, fairness, and equality for all.

25-0040 Proclamation - National Mentoring Month

Chair Allam, Vice Chair Lee and Commissioner Jacobs read the following proclamation:

"NATIONAL MENTORING MONTH"

- WHEREAS, created in 2002 by the Harvard School of Public Health and MENTOR: the National Mentoring Partnership; January is National Mentoring Month, an annual campaign to focus attention on the need for quality, consistent and competent mentors, and;
- WHEREAS, a mentor is a caring, dependable and authentic person that provides support, guidance, advice, assistance and devotes time to a young person to help youth discover personal strength to persevere and achieve their potential through a structured and trusting relationship on a regular basis; and
- WHEREAS, quality mentoring encourages and empowers youth to make positive choices, promote self-esteem and character development, support academic achievement, social-emotional learning, leadership and professional development, college readiness and career exploration; and
- whereas, the goals of National Mentoring Month are to raise awareness of mentoring, recruit individuals to mentor, equip mentors with the skills needed to support youth, encourage organizations to engage and integrate quality mentoring into their efforts with a focus on academic support, life skills training, and career readiness/workforce preparation to motivate youth to excel; and

- **WHEREAS**, during the COVID-19 pandemic, mentoring programs have stepped up to fill gaps for youth and families, connecting them with resources and ensuring mentoring relationships continue to prevent social disconnection and mitigate learning loss; and
- **WHEREAS**, research has demonstrated that mentoring programs have a significant, positive impact on a variety of academic achievement measures, including truancy and absenteeism, scholastic efficacy and engagement, school-related misconduct, and peer support; and
- WHEREAS, mentors serve a critical role in helping youth successfully complete high school and gain admission to college or training program, earn a post-secondary credential or certification, build new in- demand skills, prepare for the future of work and succeed in an ever-changing workforce; and
- WHEREAS, mentoring programs must incorporate work-based learning to prepare and connect youth with real- life work experiences where they can apply academic, technical and soft skills and develop their employability while exploring career pathways; and
- **WHEREAS**, one Durham County Strategic Plan Goal is to provide access to educational, vocational, economic and cultural opportunities while empowering citizens to choose pathways for their own success; and
- **WHEREAS**, the Durham Board of County Commissioners supports community-based mentoring programs as key community partners to support our mission for a safe, healthy and vibrant community; and
- **WHEREAS**, National Mentoring Month is the time of year to celebrate, elevate, and encourage mentoring and recruit caring adult mentors in Durham County.

NOW THEREFORE, I, Nida Allam on behalf of the Durham Board of County Commissioners do hereby proclaim the month of January 2025 as

"NATIONAL MENTORING MONTH"

and call upon public officials, educators, business and community leaders, and citizens to observe this month with appropriate ceremonies, activities and programs to:

- Recognize the valuable contributions of staff and volunteers in quality mentoring programs that empower youth, enabling them to discover inner strength and realize their full potential.
- Acknowledge the manifold benefits of mentoring, including fostering healthy identity development, promoting educational achievement, reducing juvenile delinquency, enhancing career readiness, improving life skills and outcomes, and fortifying communities.
