I. Welcome & Introductions

Chair Kevin McIver called the meeting to order, welcomed all attendees, and asked all in attendance to introduce themselves, starting with in-house attendees followed by on-line attendees.

Chair McIver moved to item III on the agenda in absence of a quorum.

III. Chair Update

Chair McIver announced that the community presenter for September's meeting will be RYSE (Resources for Youth Success & Empowerment) Assessment Center, and RED (Rehabilitation Enables Dreams) Program will be the community presenter in October.

The JCPC Board meeting time will be 4:00pm – 5:30pm.

Chair McIver moved to item VI on the agenda in absence of a quorum.

VI. Consultant Update: reported by Mr. Eddie Crews, Central Area Consultant

Mr. Crews reported that the final accounting for FY '23-'24 for the JCPC programs has been submitted except for one (1) or two (2) programs.

Mr. Crews also reported that there has been a change in legislation regarding the classification of who is considered a juvenile and who is considered an adult. Effective December 1, 2024, 16- 17-year-olds charged with an A – E felony can still go into custody in juvenile detention however, they will go straight to adult court.

Mr. Crews also reported that the facility in [Yancey-Caswell](#) County that houses 40 males will serve as a resource for Durham court services.

Chair McIver inquired about the county funding disbursements to which Ms. Roshanna Parker responded that the first two (2) disbursements have already gone out to the programs.

VII. DPS Update: presented by Dr. Melissa Watson, Director of Student Support Services

Dr. Watson opened with stating that DPS is going to continue to work on strengthening communication, transparency, and partnerships in serving scholars. Dr. Watson introduced Dr. Ernetta Cagle, who leads DPS' community partnership efforts.

Dr. Cagle stated that she serves as the Title I Community Outreach Coordinator.

(Due to technical difficulties, Dr. Cagle was unable to continue presenting)

Dr. Watson stated that she would like to invite other members of DPS to address this board's concerns and requested that the JCPC members and programs reach out to Chair McIver with their interests.

Dr. Gradesa Lockhart reported that there is now Teen Mental Health First Aid at Riverside High School for 9th graders.

Chair McIver expressed an interest in having the newly appointed superintendent, Dr. Anthony Lewis, speak to this board to which Dr. Watson stated that she will extend the invitation.

Having reached Quorum, Chair McIver moved to agenda Item II.

II. Minutes Review

Chair McIver presented the June 2024 minutes for review. DeWarren Langley aired the correction that he should be listed as 'Guest' not 'Member'. This correction was noted. Chair McIver aired the correction of the spelling of Mr. Crews' first name by adding an 'e'. 'Excused Absences' was defined as members who have communicated their inability to attend a board meeting in advance.

Chair McIver requested a motion for the approval of the June minutes with the noted changes. The motion was moved and seconded, and unanimously with noted changes.

IV. Election of Officers

Having reached a Quorum, Chair McIver opened the Floor for the election of officers. Having acknowledged that the members of JCPC have received nomination ballots in advance, the Floor was opened for nominations for Treasurer. LiBria Stephens nominated Jonathan Wilson for Treasurer who accepted the nomination. The Measurable Objectives Report from GRACED, Inc. highlights the organization's work with 21 youth during its initial year. Our goal was to serve 15 total youth as we were initially funded to serve. Out of the youth served, four youth were terminated from the program for various reasons:

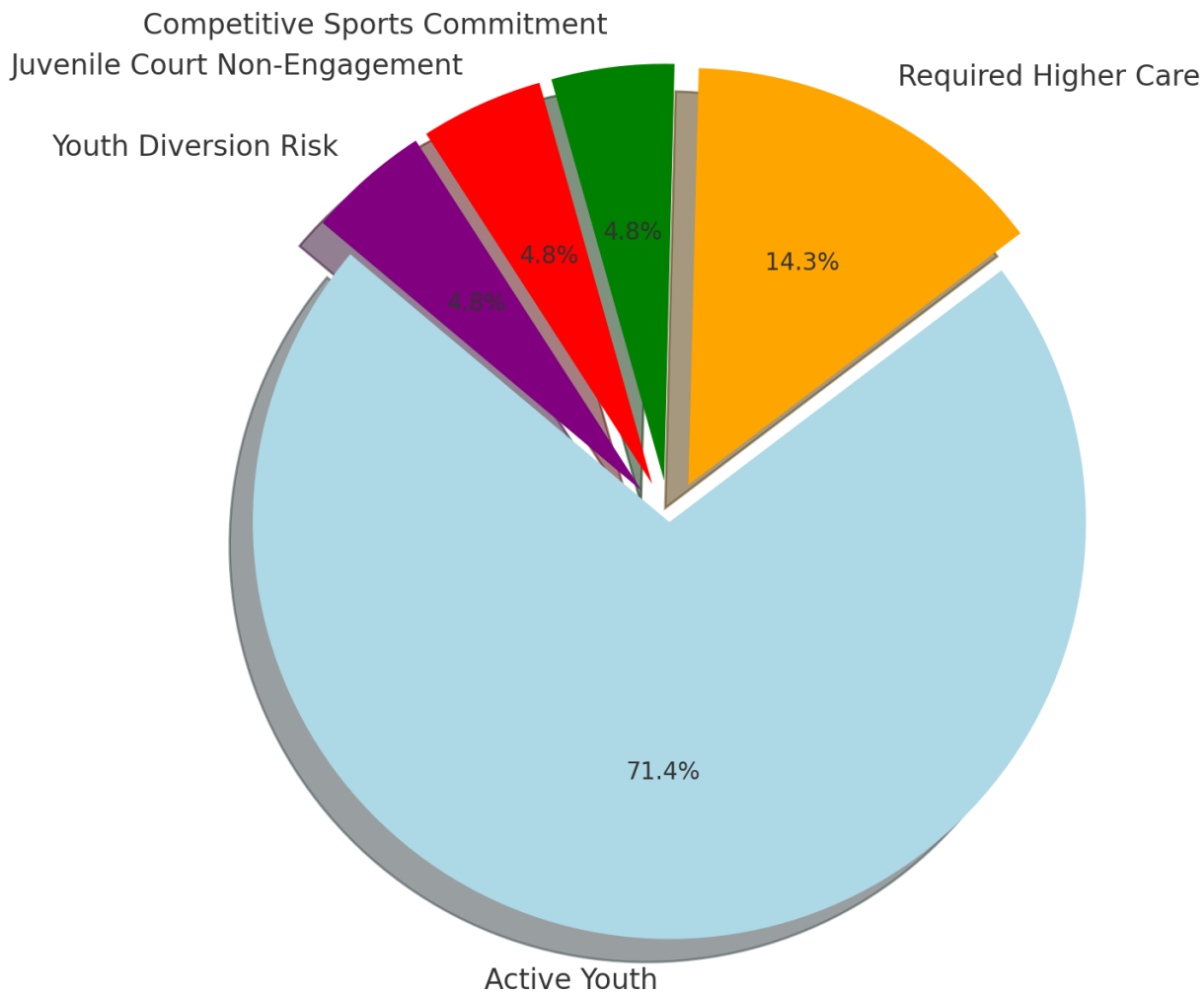
1. **Higher Level of Care Required:** Three (3) youth were identified as needing more intensive support than GRACED, Inc. could provide, necessitating their termination from the program with referrals to local programs and/or medical services to support mental well-being that was prohibiting their ability to engage.
2. **Commitment to Competitive Sports:** One youth was deeply involved in competitive sports, which required extensive travel and practice time, making it impossible for them to participate in the program regularly.

The report also addresses two referrals:

1. **Juvenile Court Referral:** One youth was referred by the Juvenile Court was unable to engage with the program leading to their termination and a debrief took place with the Juvenile Court Case Manager.
2. **Youth Diversion Referral:** Another youth referred through a diversion program was from a housing community outside of Cornwallis that posed significant risks preventing their continued participation.

This report provides a clear and honest assessment of the challenges faced in supporting youth with varying needs and highlights the organization's commitment to ensuring that each participant receives the appropriate level of care and attention.

Programmatic changes: Rolled out a new workforce development program, which was successfully completed by 40 youth in the RTP including 2 GRACED, Inc. teen participants. This is a 40-hour virtual program designed to empower middle school through collegiate level students with the knowledge and skills for successful career exploration and planning. Through engaging activities and virtual guest speakers, students gained a comprehensive understanding of diverse career paths, resume writing, elevator speech development, job search strategies, and professional development. This is a new service that we will integrate into our programming for our teens in preparation for summer jobs yearly.

Programmatic issues: None new

Programmatic achievements:

One of our youths was competitively chosen for a global youth fellowship trip to Cuba through a partnering organization, where she experienced their norms and culture. This was the first time she or any member of her family had experienced

international travel, as they lived vicariously through her. Upon our return, we both educated our youth group about the experience, which included a presentation of Cuba's cultural food, in an effort to open their minds to the possibilities that are available through stepping outside of your comfort zone and being committed to your own success.

- a) In July, our youth had access to a total of twelve (12) outings in collaboration with Durham Parks and Recreation Center (DPR) through our partnership. This year marked a significant milestone for youth involvement with our partner, DPR, as participation surged among those engaged in GRACED, Inc.'s programming at the recreation center. This boost in involvement holds promise for reducing criminal activity and gang involvement among these youth in the Cornwallis Community.
- b) GRACED, Inc. was selected as the guest presenter at the monthly Community Luncheon Roundtable hosted by Religious Coalition for a Nonviolent Durham. This was a great opportunity to share more about our program, our partnership with JCPC and solicit mentors.

Programmatic achievements:

- a) Successfully trained and onboarded (11) eleven new mentors for youth support.
- b) Presented a branding and marketing series through a partnership with a technology-based organization through place-based programming. A total of six (6) youth program participants took part in this 3-part series. This opportunity engaged our youth in a way to utilize technology to make money while exposing to new skills.
- c) In August, our youth participated in six (6) total outings in collaboration with the Durham Parks and Recreation Center. These experiences offered valuable opportunities for positive engagement, helping the youth stay connected to enriching activities during the summer break and further promoting their positive development.
- d) We hosted our 2nd annual Back to School Kickoff Party, supported by our partnership with a military sorority that generously provided each of our program participants and their siblings with book bags filled with school supplies. Additionally, we distributed 13 more book bags to youth in need, helping to support their transition back to school this week. Most importantly, GRACED, Inc. contracted a licensed mental health professional to support the development of a positive mindset as part of their back-to-school sendoff.

A question was asked, how many youths do you have that you are expecting to serve this fiscal year. Ms. Swoope replied that her caseload consists of 17 youths, and with the current support she is projecting to serve 25 youths.
